# <u>ORDER</u>

This case was last heard on 20.05.2019 and last opportunity was given to the respondent/PIO concerned to supply the certified copies of the required information to the appellant through registered post as per official record also directed to produce a copy of the postal receipt. The appellant is also advised to point out deficiencies, if any, in the information supplied on receipt of information and send the same to the PIO/Respondent by registered post with a copy to the Commission.

Sh. Manpritam Singh, S. D. O., who appeared on behalf of the respondent PIO in today's hearing, orally states that in response to the RTI request, the requisite information has been supplied to the appellant, Sh. Hardeep Singh vide letter no. 646 dated 29.03.2019. On that letter, the appellant has also put his signature as an acknowledgement of having received the requisite information but a copy of the same could not be forwarded in office of the Commission for intimation. He also submits a reply dated Nil signed by Executive Engineer, Central Works Division, PWD (B&R), Ferozepur, intimating that he is unable today's hearing and also requested to waive off the penalty of Rs. 2500/- (Rupees Two Thousand and Five Hundred only), which was imposed upon PIO/Respondent of office of Executive Engineer, Central Works Division, PWD (B&R), Ferozepur orders dated 15.04.2019 as the requisite information has been supplied to the appellant, Sh. Hardeep Singh vide letter no. 646 dated 29.03.2019 (Copy is enclosed). On that letter, the appellant has also put his signature as an acknowledgement of having received the requisite information. A written note dated 29.03.2019 signed by the appellant is also attached as an acknowledgement of having received the requisite information, through which he claimed that he is satisfied with the information supplied and asked for filing of his case. It is taken on record.

#### Appeal Case No. 3433 of 2018

After examining the documents placed on record, it is also found that the appellant, Sh. Hardeep Singh through a letter dated 29.03.2019/04.06.2019, which has been received in the Commission vide Diary No. 11074 dated 04.06.2019, has intimated the Commission that he has received the required information and asked for filing of his case. It is taken on record.

The appellant, Sh. Hardeep Singh, who appeared in person in today's hearing, also submits a written note dated 10.07.2019, stating that he has received the required information and asked for filing of his case. It is also taken on record.

After examining the documents placed on record, it emerges that the requisite information was supplied to the appellant, Sh. Hardeep Singh vide letter no. 646 dated 29.03.2019 and the appellant has also given acknowledgement, in writing, of having received the requisite information but a copy of the same had not been forwarded by the respondent PIO concerned to the office of the Commission for intimation and vide orders dated 15.04.2019, passed by the Commission, a penalty of Rs. 2500/- was imposed upon PIO/Respondent of office of Executive Engineer, Central Works Division, PWD (B&R), Ferozepur.

As the information was supplied on 29.03.2019 by the respondent PIO and during the hearing, held on 15.04.2019, no intimation was received from the respondent side as well as appellant's side, intimating the Commission that the information had been received or not, which reflects that there is no malafide intention on the part of the respondent PIO concerned in causing the delay in supplying the requisite information to the information seeker.

Moreover, after having consent of the appellant to dispose of the case and after going through the oral submission made by Sh. Manpritam Singh, S. D. O. during the hearing and reconsidering the submission made by the respondent PIO, it is found that the explanation given by the respondent PIO is genuine and facts of the instant appeal case deserve reconsideration in the interest of justice. Taking a lenient view and having made the fair and judicious evaluation of the facts of the instant appeal case, it is found that the reasons given by the respondent PIO concerned is genuine and in this particular case, he (PIO concerned )has succeeded in convincing the Bench that there is no malafide intention on his part in causing the delay in supplying the requisite information to the information seeker as well as appearing before the Commission.

Hence, penalty imposed upon the concerned PIO vide orders dated 15.04.2019 is <u>waived off</u> and show cause issued is <u>dropped.</u>

In view of all the above, the case is <u>disposed of and closed</u>. Copies of the orders be sent to the parties.
