This order may be read with reference to the previous order dated 14.05.2019.

2. The Appellant is not present today.

3. Sh Kuldeep Singh is appearing on behalf of O/o SSP Sangrur and states that the information that was available in the official record of the Respondent has already been provided to the Complainant. Further, he states that the Complainant has raised some queries in her RTI application which are not to be answered under the Act. He has also given in writing that the information as available, has been provided to the Complainant and that there is nothing pending in this regard.

4. In view of the foregoing no further cause of action is left. Hence, the Complaint case filed by the Complainant is **disposed off and closed**. Copy of the orders be sent to the parties.
