As the appellant was not present, hence, an opportunity was given to the appellant to confirm whether he has received the information, which was sent to him by the respondent PIO on 25.02.2022 and also to point out deficiencies, if any, in the information supplied to him, in writing, to the respondent PIO so that the same could be removed by the respondent concerned.

On the last date of hearing, held on 22.06.2022, Ms. Ravneet Kaur, Building Inspector(Town Planning Wing), stated that the requisite information was supplied to the appellant.

Neither the respondent PIO nor any of his representative is present in today's hearing but through an e-mail dated 10.08.2022 has intimated the Commission that he is unable to attend today's hearing. It is taken on record.

The appellant, Sh. Gurmej Lal, is not present in today's hearing. He has neither pointed out any deficiency in the information supplied to him, to the respondent-PIO, nor approached the Commission with any contrary claim in that regard.

In view of the above, it is assumed that the appellant has received the required information and is satisfied with the same, hence, the instant appeal-case is announced as disposed and closed.

ORDER

Heard in the Commission.

The RTI request is dated 19.01.2021. The complaint has been received in the Commission on 24.08.2021.

Sh. Vikram Singh, Clerk, who appeared on behalf of the respondent PIO in today's hearing, states that the requisite information has already been supplied to the complainant through registered post vide letter no. 123 dated 02.06.2022. It is placed in the case-file.

The complainant, Sh. Ranjit Singh, who appeared in person in today's hearing, states that incomplete information has been given to him by the respondent PIO.

After hearing both the parties and examining the documents placed on record, I it is found that in response to the RTI request, a point-wise reply has been given to the complainant.

Moreover, according to para 30 and 31 of the judgment passed by the Hon'ble Supreme Court of India in Civil Appeal no. 10787 to 10788 of 2011 in a case; Chief Information Commissioner & another V/s State of Manipur and another before Ld. Judges - Sh. Asok Kumar Ganguly and Gyan Sudha Misra, the Commission could not allow to information seeker(complainant) to have access of the information under Section 18 of the RTI Act, 2005;

Accordingly, the Commission could not allow access to the information to the Information seeker in a complaint case as the only remedy available to the information-seeker is given in Section 19 of the RTI Act and he (the complainant) has not exhausted the channel of approaching First Appellate Authority under Section 19 of the RTI Act.

Hence, the instant complaint case is remanded to <u>First Appellate Authority</u>, who is Director, Public Instructions (Elem.) Punjab, with the directions to decide the case as per provisions of the RTI Act, after giving due opportunity to the parties concerned, examining the evidences, documents placed on record/submitted by the parties concerned and subsequently pass a speaking order within forty five days from the receipt of this order. <u>A copy of the RTI request of the applicant be also enclosed for ready reference of First Appellate Authority, who will treat it as first appeal.</u> A copy of this order be sent to him through registered post

If concerned First Appellate Authority will not announce any order in the instant complaint case within forty five days or if the complainant would not be satisfied with the decision/announcement (which would be announced) by the First Appellate Authority, he is at liberty to approach the Commission by way of second appeal.

With this, the case is announced as disposed of and closed.

If concerned First Appellate Authority will not announce any order in the instant complaint case within forty five days or after decision/announcement of First Appellate Authority, if the complainant would not be satisfied with the decision/announcement (which would be announced) by the First Appellate Authority, he is free to approach the Commission by way of second appeal.
