Appellant, Dr. Kultarnjit Singh is not present for today's hearing but a letter dated 29.08.2019 along with supporting documents has been received in the Commission vide diary no. 16863 dated 03.09.2019 stating that he is out of country and will be returned on 14.09.2019. In that letter he requested for an adjournment in this case. This letter is taken on record.
4. After examining the case file, a last and final opportunity is given to the appellant to represent this case in person or through his representative(s) on the next date of hearing to clear the facts of this case, failing o which case will be decided on merit basis.
5. Matter is adjourned for further hearing on **15.10.2019 at 11:00 AM.**
