appellant that the information cannot be supplied after its creation.

4. It is appropriate to mention the instructions issued by the Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training No. 10/2/2008-IR dated 12.6.2008 to transfer the RTI application of the appellant under Section 6(3) of the RTI Act, 2005 to 'public authority' and not to the 'public authorities'.

5. Also the appellant is apprised that the most of the sought information is available on the website of the Government of Punjab i.e. www.punjab.gov.in and Punjab Vidhan Sabha i.e. www.punjabassembly.nic.in.

6. Keeping in view the above, no further directions can be given to the respondent-Public Information Officer as per the provisions of the RTI Act, 2005. Therefore, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed.
