1. The RTI application is dated 26.02.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 02.06.2020 and the second appeal was filed in the Commission on 03.09.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. Notice of hearing was issued to the parties for 10.11.2020 by the Commission through Video Conferencing facility in the office of D.C. Ludhiana. Shri Munish Kumar Aadiya, appellant comes present to attend the hearing through V.C. He states that he has sought a copy of register in which the ownership of Property No.B-5-966/2 is entered as also the copy of document if any court case relating to this property is pending, as CC is written against this property number.
