ORDER

This order may be read with reference to the previous order dated 9.9.2021 vide which the directions were issued to the respondent-Public Information Officer to comply with the order of the Commission. However, the appellant vide his representation dated 4.10.2021 informed that the respondent-Public Information Officer has not complied with the order of the Commission.
