It was also directed that if information is not available, he may give proper reply in the form of an affidavit duly signed by PIO as to why the information cannot be supplied. He was also directed to appear in person or through his representative on next date alongwith postal receipt for having supplied the requisite information to the appellant.

Today, the Appellant is absent. He has, however, sent a letter dated 07.12.2018 which is available in the file, stating that no information has been received by him. He has also intimated vide that letter that he would not be able to come on 10.12.2018.

Appeal Case No.2293 of 2018

No body is present on behalf of the PIO/Respondent. An e.mail. dated 10.12.2018 has been received from him that he is undergoing training today i.e. 10.12.2018 at the Mahatma Gandhi State Institute and such will not be able to attend the appeal case in the Commission.

The attending of training programme today by the PIO is no excuse for not being able to supply the information, as it was directed on the last date of hearing, to supply the information by registered post and also to attend the Court in person or through his representative.

In view of the above, PIO O/o, Executive Engineer Provincial Division, PWD (B&R), Ferozpur will Show Cause under Section 20 (1) of the RTI Act, as to why penalty be not imposed upon him for willful delay in supplying the information to the information-seeker under the provisions of the RTI Act, 2005.

In addition, the PIO is also hereby given an opportunity under Section 20(1) provision thereto, for a personal hearing with the sought for information before the imposition of such penalty on the next date of hearing.

PIO/Respondent is directed to supply the information to the Appellant before the next date of hearing by registered post and bring postal receipt alongwith him on the next date of hearing, otherwise strict action would be taken.

The Appellant is advised to point out discrepancies, if any, after the information is received by him and come present on the next date of hearing.

The case is adjourned for **12.02.2019 at 11.00 AM.**
