He also states that requisite information has been sent to the appellant.
2. Sh. Ajay Bansal, the representative of the appellant, states that incomplete information has been received. He pointed out deficiencies as follows:
 - a) Point 1 – Information from January 2017 to May 2017 has not been received.
 - b) Point 2 – Appellant Satisfied
 - c) Point 3 – Not received certified copy and copy of concerned register.
 - d) Point 4 – Balance in P.F Account of Appellant and also Name of the Bank(s) in which credit is lying.
 - e) Point 5, 6 & 7 – Not Received.

3. After hearing the both the parties and examining the documents placed on record, the **respondent PIO is directed to represent this case in person on next date of hearing** along with the direction to remove deficiencies pointed out by the appellant satisfying the RTI application (as mentioned above in point no. 2 of this order) by the **next date of hearing**, failing to which further action under section 20(1) of RTI would be enhanced against the respondent PIO.
4. The matter is adjourned for further hearing on **08.01.2019 at 11.30 AM.**
