### **ORDER**

4. After hearing both the parties and going through the record available on the case file, it is revealed that it is not the job of the CPIO to collect and therefore collate the information from different PIOs of different public authorities and thereafter supply the same to the appellant. Under-section 6(1)(a) a person seeking information has to apply to the concerned public authority, who is the custodian of the information. The appellant is advised to seek information regarding tender with its number and date afresh to the concerned public authority for supply of the information. With these observations, the present case is **disposed of** and **closed**. Copies of the order be sent to the parties.

On the other hand, the disclosure of which could cause unwarranted invasion of the privacy of that individual. The Supreme Court further held that such information could be disclosed only if it would serve a larger public interest."*

5. After hearing both the parties and going through the documents available on the case file, it is revealed that no information is to be supplied to the appellant regarding personal information of third party as the matter is between the employee and the employer. The Commission is satisfied with the reply given by the respondents to the appellant. Hence, the present case is **disposed of** and **closed**. Copies of the order be sent to the parties.
