ORDER:

The appellant through RTI application dated 10.01.2020 has sought information regarding status of enquiry of Improvement Trust Kartarpur as per letter received from the office of D.G.Vigilance Punjab, Chandigarh – copy of all types of petty purchases done in Trust from 01.01.2014 to 18.11.2018 – list of tender work got done by trust 01.01.14 to 18.11.2018 from the office of Additional Chief Secretary Local Govt Department Punjab, Chandigarh. The appellant was not provided the information after which the appellant filed first appeal before the first appellate authority on 09.03.2020 which took no decision on the appeal.

The case came up for hearing last on 29.09.2020 through video conferencing at DAC Ludhiana. The appellant informed that he has received a letter dated 01.05.2020 from the PIO stating that since an inquiry is pending no documents can be provided. As per the appellant, the PIO has also not supplied the information on points b &c.

The appellant also stated that in an earlier RTI application, the Improvement Trust had supplied an affidavit that the information is not available in their office since the record had been handed over to the Punjab Vigilance Department because of an ongoing enquiry.

Having gone through the RTI application and its subsequent trail, it was observed that the appellant had filed the RTI application in the office of Chief Secretary, which transferred it to the Secretary Vigilance department Punjab, and the Vigilance office further transferred it to Additional Chief Secretary, Local Govt. Pb, Chandigarh. On 06.02.2020.

Sh.Sanjeev Kumar, PIO-Local Govt Department appeared late and informed that the enquiry is pending and the reply has been sent to the appellant.

The respondent was directed to look into the matter and report to the commission that under whose custody the information exists regarding points B & C (copy of all types of petty purchases done in Trust from 01.01.2014 to 18.11.2018 – list of tender work got done by trust 01.01.14 to 18.11.2018). If the information is available in the custody of the vigilance office, the respondent was directed to procure it and provide the information to the appellant.

The Commission did not find that providing information about points b &c would hamper the vigilance inquiry, though there is nothing on the file to establish that any such inquiring is pending.

Appeal Case No. 1320/2020 & 1307/2020

The PIO-Vigilance office was directed to provide copies of points B & C (copy of all types of petty purchases done in Trust from 01.01.2014 to 18.11.2018 – list of tender work got done by trust 01.01.14 to 18.11.2018) to the respondent if it is in its custody. If the record is not in the custody of the vigilance department anymore, the Vigilance Department was directed to provide the noting through which the record has been handed back to the Improvement Trust.

Hearing dated 10.12.2020:

The case has come up for hearing today through video conferencing at DAC Ludhiana. Both the parties are absent.

The PIO vide email has informed that the information on points-2 & 3 has been provided to the appellant.

The Commission has also received a letter from the appellant on 17.11.2020 stating that a similar appeal case No.1307 of 2020 is fixed for hearing in the Court of SIC-Preety Chawla and has requested to fix both the cases in one court.

The appeal case No.1307 of 2020 has been transferred from the bench of SIC-Preety Chawla to this bench. In this case also, the appellant has sought exactly the same information from the office of SP-Vigilance Bureau, Jalandhar. Both the cases are clubbed together.

As per the email of the respondent the information stands provided. Since the information has been provided, I dispose of the case, however, with a stricture to the appellant to not follow this practice of filing similar cases in the commission as the appellant while filing an appeal in the commission undertakes a pledge that the matter under appeal or complaint has not been previously filed or pending or decided by any State Information Commissioner.

No further course of action is required. The case is **disposed off and closed**.

The PIO was again directed to provide complete information to the appellant within 15 days.

On the date of hearing on **24.02.2020**, the respondent submitted his reply which was taken on the file of the Commission. The respondent informed that the information has been provided to the appellant. The appellant was not satisfied and stated that the information provided is not relevant as he has asked for action taken on his applications sent to the PIO through email. Hearing both the parties, the Commission observed that the respondent needs more clarification from the appellant. The respondent was directed to visit the chamber of the appellant in District Court, Ludhiana on 25.02.2020 at 01.00 PM and get the clarification on the information sought by the appellant. The PIO was also directed to provide complete information as per the RTI application.

The respondent did not bring reply to the show cause notice. The PIO was given one last opportunity to submit reply to the show cause notice.

The PIO-O/o Chief Accounts Officer (Pension) was issued a **show cause notice and directed to file a reply on an affidavit.** The PIO was again directed to provide the information to the appellant within 10days.
