1. The RTI application is dated **27.10.2020** vide which the appellant has sought information **regarding the Additional Commissioner's letter - No 1499-1502/ACCR/D dated 27.10.2020 etc.**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **10.12.2020** and Second Appeal was filed in the Commission on **9.2.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **14.7.2021**.
2. Both parties are present. The respondent PIO-cum-XEN, Harwinder Singh, from B&R Department of Zone A, submitted: i) That the letter mentioned in the RTI application was issued by the office of MC Ludhiana and copy of this is available at that office. However, the appellant's lawyer Sukhjinder Kaur states that she has received the requisite information from the PIO Zone B and states that it is now only a question of 8 months delay in addressing the RTI application.
3. The Commission notes that most of the delay period pertains to a time when there were State wise restrictions owing to the pandemic. The delay is therefore condoned.

1. The RTI application is dated **17.11.2020** vide which the appellant has sought information **regarding street lights in illegal colonies Zone-A, B, C, and D,** as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **20.12.2020** and Second Appeal was filed in the Commission on **9.2.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **14.7.2021**.

2. Both parties are present. The respondent PIO represented by Harjeet Singh, SDO from Zone-B and Harwinder Singh, PIO-cum-XEN from Zone-A, and Avtar Singh, Junior Engineer from Zone D, have all submitted separate replies wherein they have clarified that the Municipal Corporation has not installed any Streetlights in illegal colonies. It is this Commission's view that the reply filed the respondents adequately addresses this RTI application.
