2. The respondent PIO is absent without intimation. At the last hearing on 24.11.2021, the respondent PIO had offered to arrange an inspection of the record at 11.00 am on 29.11.2021. Sh. 3. The respondent PIO's conduct is highly questionable and evidently in violation of the RTI Act 2005. This Commission deems it fit to serve the respondent PIO with this Show Cause Notice.

As per a subsequent letter from the respondent PIO, (No. 60 Dated 27.1.2022) the appellant submitted a list of industries through whatsapp on 2.12.2021 and was conveyed on 17.1.2022 to visit the office and inspect the file. The appellant however, contends that even though they visited on 17.1.2022, they were not shown any record.
