**ORDER** 

The RTI application is dated 16.11.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 21.1.2021 and second appeal was filed in the Commission on 17.2.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). - 2. The appellant states that no information has been supplied by the respondents. However, the representative of the respondents states that regarding Point No. 1 of the RTI application, no information can be supplied after its creation as the appellant has sought the name of the officer who signed the letter No. 8/cvr dated 28.6.2013. Therefore, no information can be supplied to the appellant in this regard. Regarding Point No. 3 of the RTI application, the representative of the respondents states that it relates to the Commissioner of Police, District Ludhiana. Regarding Point No. 2 of the RTI application, the reply of the respondents is not tenable.
- 3. After hearing the parties and going through the record available in the case file, the plea taken by the respondents regarding Point No. 1 is accepted. Regarding Point No. 2 the respondent-Public Information Officer o/o the Deputy Commissioner, Ludhiana is directed to supply the copy of rules as has been sought by the appellant. Regarding Point No. 3 of the RTI application the Public Information Officer o/o the Commissioner of Police, District Ludhiana is impleaded as necessary party in this case to file the reply/supply the information to the appellant before the next date of hearing under intimation to the Commission. A copy of the reference of the Deputy Commissioner, District Ludhiana along with the RTI application of the appellant is being **sent** along with this order.
