1. The complainant, **Surinder Kumar**, filed this RTI application dated **15.3.2022** and sought information regarding illegal commercial / non-commercial buildings, from the PIO o/o **Tehsildar Shahkot, Jalandhar**. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on **24.5.2022**. Notice was issued to the parties for first hearing in the Commission on **10.8.2022**.

4. The Commission however, notes that both the respondent and the appellant have not deemed it fit to attend this hearing. The respondent PIO is herewith directed to submit a written explanation for his absence at today's hearing without intimation to this Commission. This must be done within Ten days of receipt of this Order.
5. This Complaint Case is accordingly Disposed of.
