However, keeping in view the prevailing situation due to second wave of Covid-19 pandemic, last and final opportunity is afforded to the Respondent-PIO to supply the authenticated information to the Appellant **within 15 days** under intimation to the Commission failing which **Show Cause Notice** under the RTI Act 2005 will be issued to him. He is further directed to be present on the next date of hearing to present the case personally through Cisco Webex.

4. Adjourned and to come up on **15-07-2021 at 11.00AM** for further hearing **through CISCO WEBEX MEETING ID No. 159 864 6555**. Copies of the order be sent to the parties.
