**ORDER** 

1. This order may be read with reference to the previous order dated 08.01.2019.

2. Respondent, Advocate, S.S. Brar states that reply as per RTI application has already been

supplied to the appellant and nothing is left to be supplied. He added that appellant demanded the

requisite information from the year 2001 but the University came into existence in year 2012. He

further added that requisite information is a kind of personal nature instead of Public interest, which

cannot be supplied to the appellant as personal information is exempted as per Section 8 of the RTI

Act. He also requested to close the case with the plea that providing information will compromise the

security plan.

3. Appellant, Sh. Sukhjeet Pal Singh is not present for today's hearing but two emails dated

09.02.2019 and 11.02.2019 have been received from the appellant by the Bench of Undersigned,

which are taken on record.

4. After hearing the respondent and examining the case file, we are of the considered view that

supplying information will compromise the security plan and design of the college and receiving

information can breach the environmental security. Moreover, the requisite information is not in

Public Interest.

It is also observed that both emails which were received from the appellant, Sh. Sukhjeet Pal

Singh are not relevant with the RTI application to pass order in the present case i.e. Appeal Case

No. 1544 of 2018.

5. In wake of above, no further cause of action is required in this case. Therefore, the instant

appeal case is disposed of & closed.
