ORDER:

The case was last heard on 10.12.2018. The Complainant Sh.Wassan Singh Goraya was absent, but had sent e.mail dated 10.12.2018 requesting for another date.

On the last date, Sh.Balbair Singh, Executive Assistant who was present on behalf of the PIO, Punjab Skill Development Mission had produced letter dated 10.12.18 enclosed therewith copy of the information supplied to the Complainant vide letter dated 06.08.2018 on points No.1 to 5 and regarding supply of information on other points, the application had been transferred to the Director, Technical Education & Industrial Training Punjab.

The APIO, Ms. Rajni Mahajan, and Sh.Rachhpal Singh, Sr.Asstt. o/o The Director, Technical Education & Industrial Training, (Technical Education Wing), Punjab had submitted letter from the PIO dated 10.12.2018 that information regarding points No.6, 7 & 8 would be supplied to the complainant as is available in their office.

Complaint Case No.1007 of 2018

PIO/Respondent, o/o Director, Technical Education & Industrial Training (Technical Education Wing) was directed to supply the information to the Complainant by registered post. The Complainant was also advised to point out discrepancies, if any, after the information is received by him, by registered post.

Today, Sh.Wassan Singh Goraya, Complainant comes present. On behalf of PIO/Respondent, Smt. Monika Bansal, Supdt. (TE Wing) and Sh.Rashpal Singh, Sr.Asst.(IT Wing) come present.

After going through the file, Point-wise discussion is initiated with both the parties. Regarding reply to Points NO.1 & 2, it is observed that Annexures A & B are required to be supplied and Regarding Point No.3, Annexures C is required. Regarding Points No.3, 4 & 5, the position needs to be clarified correctly. Regarding Point No.6, Maharaja Ranjit Singh Punjab Technical University, Bathinda has supplied the information.

During the proceedings in the court, while other points are being discussed, on each point the complainant is asked to inform whether he is satisfied with the information. In spite of the fact that on some points the Court felt that the information is in order, but on persuading the Complainant regarding the correctness of information, he has not behaved properly and is adamant not to listen to the observations of the Court. It is observed that he does not know as exactly, what information has been sought by him. On the asking of the Court, he states that he is member of a team which seeks information under RTI Act. One member prepares the RTI Application to seek information and the other member appears before the Court. It is also not appropriate for the Complainant not to adhere to the Court ethics. Due to this unbecoming attitude of the complainant, the Court is unable to go ahead with the hearing of the present complaint.

In view of this, it will be appropriate to transfer the complaint to any other Bench. Deputy Registrar may please put up this complaint case before Hon'ble C.I.C. for transfer of the same to some other Bench.

Due to this unbecoming attitude of the complainant, the Court is unable to go ahead with the hearing of the complaint.

In view of this, it will be appropriate to transfer the complaint to any other Bench. Deputy Registrar may please put up this complaint case before Hon'ble C.I.C. for transfer of the same to some other Bench.
