The respondent PIO concerned is directed to send the requisite information to the applicant through registered post or in person at his residential address by the next date of hearing.

The applicant is advised to confirm whether he has received the information or not. He is also advised to point out deficiencies, if any, in the information supplied to him, in writing, to the respondent PIO concerned and the respondent is directed to remove the same.

ORDER

Sh. Surendera Bhanot appeared on behalf of the applicant, Sh. Kuldip Singh Walia, in today's hearing.

After examining the documents placed on record, it is found that a notice of hearing was issued in this case by the Commission vide letter no. 6368-6370 dated 13.03.2018 in the name of Public Information Officer, of office of Secretary, Baba Zorawar Singh, Co-operative House Building Society, Banur and First Appellate Authority of office of Deputy Registrar, Co-operative Societies, Pb., Mohali alongwith enclosures (i. e. copy of RTI application, a copy of First appeal and a copy of Second appeal) and fixed for hearing for 04.04.2018 before Hon'ble State Information Commissioner, Professor Viney Kapoor Mehra and a show-cause notice was issued, afterwards, the case was fixed for hearings for 24.05.2018, 19.07.2018, 28.08.2018 and vide orders dated 28.08.2018, the case-file was sent to the registry to allocate the case to another Bench and further, the case was fixed for hearing before the Bench of the undersigned for 09.01.2019 and on that day, the respondent concerned was directed to file a reply, in writing, mentioning that 'Baba Zorawar Singh, Co-operative House Building Society' does not fall within the definition of 'public authority' as defined under the RTI Act.

It is for intimation that on the hearing, held on 06.02.2019, Sh. Pawan Kumar Sharma, Advocate, appeared in another case before the Bench of the undersigned and on that day he had submitted a reply dated 06.02.2019 on behalf of PIO of office of Baba Zorawar Co-op. House Building Society, Banur, intimating the Commission that copy of RTI application as well as copy of First appeal and other documents has not received alongwith notice of hearing in the office of the 'respondent institute' i. e. 'Baba Zorawar Singh, Co-operative House Building Society'. It has been placed in the case-file. On that day, Sh. Prem Chand Verma, Superintendent also appeared on behalf of D. R. of office of Co-op. Societies, Mohali.

An opportunity is also given to the respondent PIO concerned to file a reply, in writing, in support of his contention that 'Baba Zorawar Singh, Co-operative House Building Society' does not fall within the definition of 'public authority' as defined under the RTI Act, by or on the next date of hearing.

A copy of this order also be sent to Deputy Registrar, Co-operative Societies, Pb., Mohali through registered post with the advice to ensure presence of any of official of his office as a representative to represent this case on the next date of hearing to clear the facts of this case.

The case is adjourned to 6th March, 2019 (Wednesday) at 11:00 A. M.
