O R D E R

Shri Malkit Singh, appellant filed RTI application dated 29.03.2018 and he sought some information from the office of the PIO regarding tenders of Water Courses of 52 villages of Malout Tehsil and 39 villages of Lambi Tehsil. The appellant stated that no information has been provided to him by the PIO.

I have gone through the previous Order dated 13.11.2018. As the information sought by the appellant is voluminous in size, so I ordered an inspection of the records and directed the PIO to co-operate the appellant for inspection and provide maximum 350 pages of information, which will be claimed by the appellant, but the appellant had not visited the office of the PIO for inspection.

Today, at the time of hearing the appellant is agitating that he is in need of all the information which he had sought through his RTI application dated 29.03.2018 regarding 91 villages of Tehsil Malout and Tehsil Lambi.

The PIO has submitted that his office has received the RTI application of the appellant on 03.04.2018 and after that he had issued a letter dated 16.04.2018 to the appellant, Shri Malkit Singh for inspection of the record, but when he did not come for the inspection, then the PIO wrote another letter No.788-89 dated 16.05.2018 and asked the appellant to deposit an amount of Rs.9,77,908/- as assessed fee for the information, as the information sought by him is voluminous in size.

The appellant stated that he has received the letter dated 16.05.2018 written by the PIO through which he was asked to deposit the assessed fee and he further agitated that the PIO has asked for the expenditure for preparing the maps by the Patwari and so far as this fee is concerned the PIO is not authorized to ask for the labour charges of Rs. 1,57,632/- of Patwari for preparing the maps.

The appellant stated that he is still ready to pay the assessed fee except the labour charges of Patwari of Rs.1,57,632/-. He requested that he be given time period of 15 days to deposit the amount of assessed fee.

So, the appellant is directed that he should deposit the amount of assessed fee except the labour charges of Patwari of Rs.1,57,632/- with the office of the PIO within 15 days and in case the appellant deposits the assessed fee in the office of the PIO, then the PIO should provide the sought for information to the appellant within 30 days from the deposit of the assessed fee.

With this observation the present appeal case is **disposed of and closed**.

The PIO is directed that the Compliance Report be sent back to the Commission.
