So, as per the view passed by the Hon'ble High Court and as per the provisions and rules of the RTI Act, 2005 it is mandatory for the information seekers to annex identity proof, which in the present case the applicant has not annexed along with the RTI application dated 18.10.2018.

So, the present appeal case is disposed of and closed with the observation that in case the appellant wants to get sought for information from the office of the PIO, then he should provide his identity proof to the PIO within 15 days and in case the appellant provides his identity proof within the above said period, then the PIO should provide him the information which he sought through his RTI application dated 18.10.2018.

With this observation the present appeal case is **disposed of and closed**.
