ORDER:

The date of RTI Application is 07.10.2020, the date of First Appeal is 18.11.2020 and the date of Appeal filed in the Commission is 05.02.2021.

In today's hearing, the Appellant, Sh. Jasveer Singh Sidhu states that no information has been supplied to him and further requests for the same.

On the other hand, Sh. Madan Lal connected through Cisco Webex and states that Sh. Munish Kumar Bansal, Head Teacher, Government Primary School, Dhobiana, Bathinda has authorized him to represent this case on his behalf. In relating to this, an email dated 08.05.2021 has also been sent to the Commission.

After asking Sh. Madan Lal whether he is from the concerned Department and what is his designation in the office to which Sh. Madan Lal states that he is just a friend of Sh. Munish Kumar Bansal, Head Teacher as Sh. Munish Kumar would not be able to appear today, which is not acceptable as he should authorize a concerned person from his concerned office only.

Also, a letter dated 03.05.2021 has also been received in the Commission from Sh. Munish Kumar Bansal in which Sh. Munish Kumar Bansal has been directed to explain the same before the Commission before the next date of hearing.

Commission takes a serious view of the casual approach of the Respondent / PIO as none comes present from the concerned Department today and no information has been supplied to the Appellant till date.

In view of the above, a show cause notice under Section 20 (1) of the RTI Act is issued to the 'concerned' Public Information Officer O/o The Head Teacher, Govt. Primary School, Dhobiana, Bathinda, as to why penalty be not imposed upon him for willful delay in supplying the information to the RTI Appellant and as to why the compensation be not awarded to the information-seeker under the provisions of the RTI Act, 2005.



In addition, the PIO is also hereby given an opportunity under Section 20(1) provision thereto, for a personal hearing with the sought for information, before the imposition of such penalty on the next date of hearing. **A copy of the RTI Application be sent to the concerned PIO along with this order.**

The concerned PIO is directed to supply the requisite information to the Appellant by hand or through registered post before the next date of hearing positively and if the information is not available with them then the PIO is directed to file a proper reply in the form of an affidavit explaining the reason, why the information could not be supplied to the Appellant till date, failing which an action would be taken against the concerned PIO.

The PIO is also directed to submit the copy of the postal receipts to the Commission vide which information would have been supplied to the Appellant, by the next date of hearing.

Sh. Munish Kumar Bansal, Head Teacher, Government Primary School, Dhobiana, Bathinda is directed to appear along with information on the next date of hearing which is going to be heard through Cisco Webex Meetings Software.
