ORDER:

1. The Appellant/Complainant filed above mentioned appeal/complaint cases in the Commission dated 05.02.2021. Accordingly, the cases are fixed for today.
2. Respondent, Sh. Davinder Attri pleaded that the sought information cannot be supplied as Deputy D.A. Legal C.P. Jalandhar has advised them to not supply the requisite information to the appellant, through letter dated 11.09.2020 vide letter no. 267-D. He further added that appellant in the present case, there is **no tangible public purpose** which has been cited by the appellant.
3. The Commission, after hearing the submissions of both the parties and perusing the records, observes that the **PIO has denied information of the RTI application; however, no exemption clause has been mentioned. Here, it is pertinent to bring to the notice of the PIO that information can be denied only under the relevant provision of the RTI Act and in particular under Section 8 of the RTI Act, if, at all applicable and in the present case, the PIO while explaining as to why the information could not be shared has not mentioned any exemption clause in his reply, which makes the reply incomplete.** Under such circumstances, the PIO is directed to visit the RTI application afresh and share that information which is not voluminous with the appellant in the form of certified copies. The PIO should note that in case she is denying sharing any information being related to a third party, the proper exemption clause under the RTI Act should be claimed and justified by him.
