1. - 4. Adjournment for today was given as respondent, Ms. Kulwinder Kaur intimated the Commission on the previous hearing (28.04.2022) that another Appeal case 1877 of 2021 is fixed for today and matter is similar but she did not bother to represent both the cases today.
- 5. The absence of the PIO is viewed seriously as it also affects hearing and disposal of the case.

  A final opportunity is awarded to respondent PIO, Ms. Kulwinder Kaur to appear in person on the next date of hearing along with concerned person from the concerned branch to clear the facts of this case at PSIC Office, Chandigarh, failing which stern action will be initiated against her as per RTI Act, 2005.
