has nothing to say and the Commission shall proceed to take further proceedings against him ex-

#### ORDER

Heard through facility of Software/application 'CISCO Webex Meetings'.

The RTI request is dated 07.11.2020. First appeal is dated 23.02.2021. Second appeal has been received in the Commission on 20.05.2021.

The appellant, Sh. Gurpreet Singh, who appeared in person in today's hearing, states that he has pointed out deficiencies in the 'supplied information' through a letter dated 03.03.2022 and sent the same to the respondent PIO with a copy to the Commission but no information has been given to him by the respondent PIO till date. It (letter dated 03.03.2022) is placed in the case-file.

Neither the respondent PIO nor any of his representative is present in today's hearing.

After examining the documents placed on record, it is found that a show-cause notice was issued vide orders dated 25.04.2022 with the directions to supplying the required information to the information-seeker, after removing the deficiencies, which were pointed out by the appellant through letter dated 03.03.2022 but the concerned PIO neither attended the court through Webex nor supplied the requisite information till date despite the fact a copy of the letter dated 03.03.2022 through which deficiencies were pointed out by the appellant was sent to the respondent alongwith order dated 25.04.2022. It reflects that he is trying to delay in supplying the required information to the information-seeker. The Commission took a serious view of this casual approach of the respondent PIO.

For making delay in supplying the requisite information to the information-seeker under Section 20 (1) of the RTI Act, a penalty of Rs. 10,000/- (Rupees Ten Thousand Only) is imposed upon the concerned Public Information Officer office of Director, Public Instructions (Colleges) Punjab, S. A. S. Nagar. A copy of this order be sent to him through registered post.
