**ORDER:**

This order may be read with the reference of the previous order dated 16.06.2020.

In today's hearing, the Complainant, Sh. Harjeet Singh states that no information has been supplied to him and further discusses about the letter dated 16.06.2020, which has been received by him.

On this, the ATP, Sh. Sunil Kumar states that a letter number 810/ATP-B/D dated 16.06.2020 has been sent to the Appellant as well as the Commission in which it is clearly mentioned that the information relating to para number 01 and para number 02 of the RTI request relates to the Property Tax Branch, Zone-B and further it is written that the information relating to para number 03 relates with Tehabzaari Branch, Zone-B and the information relates to para number 4, it also relates with Tehabzaari Branch, Zone -B. On further discussion, he states that the land is passed as 'Commercial' and a copy of site plan had already been supplied to the Appellant in another case i.e. 66 of 2019 and 97 of 2019 and the same has also been written in the same letter dated 16.06.2020.

After hearing, both the parties, it has been observed that as per Sh. Sunil Kumar, ATP Zone-B, the information related with para number 01 and 02 of the RTI requests relates with Property Tax Branch and the information relating to para number 03 and 04 relates with Tehabzzari Branch. So, both i.e. PIO O/o Municipal Corporation, Zone -B, Property Tax Branch, Ludhiana and O/o PIO, O/o Municipal Corporation, Zone-B, Tehabzaari Branch, Ludhiana are impleaded as a party.

On asking about the in charge of both the department's, Sh. Sunil Kumar states that Mr. Abdul Sattar, Superintendent is handling both the departments i.e. Property Tax Branch, Zone-B as well as Tehabzaari Branch, Zone-B.

The Complainant is advised to go through the requisite information, once he receives the same from the Respondent/PIO and point out deficiencies in written, if any, to the Respondent/PIO through registered post or through email, with a copy to the Commission, failing which the case will be decided on merits.

**ORDER:**

This order may be read with the reference of previous order dated 16.06.2020, in which Sh. Mohan Singh, ATP from Zone-D requested for an adjournment and assured that information will be supplied to the Appellant before the next date of hearing.

In today's hearing, the representative of the Appellant, Sh. Sukhjinder Kaur states that the information which has been supplied to them is not relating to the RTI Application as the Respondent is sending them unwanted information. She further states that in the Appellant's RTI they are simply asking about the action taken after the orders passed by the Hon'ble High Court of Punjab and Haryana in CWP 4886 of 2003 and the name of the person who is responsible for not implementing the orders (i.e. point number 05 and 06 of the RTI request).

On this, the Superintendent, Sh. Parvinder Kumar Kalra explains the position of the RTI case by stating that the Ms. Kamalpreet Kaur Brar, I.A.S who was the Commissioner of Municipal Corporation, Ludhiana that time and she passed the orders for conducting the inquiry and for the same Sh. Rishi Pal, P.C.S officer was assigned for inquiry vide dated 04.06.2020. And the inquiry is still in process and as soon as it will be completed then the information will be supplied to the Appellant.



On asking Sh. Parvinder Kumar about the current Commissioner of Municipal Corporation, Ludhiana. He states that Sh. Pardeep Sabharwal, I.A.S. is the current Commissioner of Municipal Corporation, Ludhiana.

**After discussing with both the parties, Sh. Pardeep Sabharwal, The Commissioner, Municipal Corporation, Ludhiana is directed to go through the facts of the case and ensure that the enquiry report should be submitted to the Court (after completion) on the next date of hearing positively.**

**A copy of this order be sent to Sh. Pardeep Sabharwal, the Commissioner, MC, Ludhiana along with the RTI request.**

The PIO/Respondent is directed to supply remaining information i.e. point number 5 and 6 of the RTI Application to the Appellant, by registered post or through email along with a copy to the Commission, before the next date of hearing. The Respondent/PIO concerned is also directed to appear in person along with the postal receipt or submits a copy of email, through which information would be sent to the Appellant, on the next date of hearing.

The Appellant is advised to go through the requisite information, once he receives the same from the Respondent/PIO and point out deficiencies in written, if any, to the Respondent/PIO through registered post or through email, with a copy to the Commission, failing which the case will be decided on merits.

Both the parties are directed to be present on the next date of hearing which is going to be held through **Video Conference Software/ Application Cisco Webex Meetings Software.**
