





The PIO stated that letter no.6469 dated 01.10.2019 was written to the appellant and he was asked to deposit Rs.3,800/- as assessed fee for the cost of sought for information, but till today the appellant has not deposited the assessed fee with the office of the PIO.

## Complaint Case No. 363 of 2018

ORDER

Shri Pawan Kumar Sharma (Advocate), complainant/applicant filed RTI application dated 02.02.2018 and sought some information from the PIO, O/o Deputy Registrar, Co-operative Societies, Mohali.

#### Today the case is heard through CISCO Webex Meetings Software.

I have gone through the case file. The complainant/applicant, Shri Pawan Kumar Sharma, Advocate filed RTI application dated 02.02.2018 and the case was heard by the Bench of State Information Commissioner, Prof. Viney Kapoor Mehra. On 14.12.2018 the case was disposed of and closed in the presence of Shri Pawan Kumar Sharma, Advocate, complainant/applicant and Shri Abhitesh Singh Sandhoo, Deputy Registrar, Co-op. Societies, Mohali.

A Show Cause Notice was issued to Shri Abhitesh Singh Sandhoo, Deputy Registrar, Co-op. Socieities, Mohali vide Order dated 20.09.2018 and he was directed to show cause in writing or through affidavit under section 20(1) of the RTI Act as to why penalty be not imposed upon him for willful delay/denial of the information to the RTI applicant.

Though the case was disposed of and closed on 14.12.2018 on the assurance of the respondent, but the complete information was not provided to the complainant/applicant. Then the complainant/applicant sent a representation to the Commission and vide Order of the Hon'ble Chief Information Commissioner, Punjab, the case was re-opened and the case file was sent to the present Bench for hearing. It is written by the Deputy Registrar of the Commission that though the Show Cause Notice was issued to Shri Abhitesh Singh Sandhoo, but he has not filed any reply to the Show Cause Notice and the Show Cause Notice has yet not been decided.

# Complaint Case No. 363 of 2018

So, Shri Abhitesh Singh Sandhoo, the then Deputy Registrar, Co-op. Societies, Mohali, now posted as Deputy Registrar, Co-op. Societies at Fatehgarh Sahib is directed that he should file reply to the Show Cause Notice through duly attested affidavit and send it to the Commission before the next date of hearing and an opportunity of personal hearing will be afforded to him on the Show Cause Notice. In case he would not file reply to the Show Cause Notice, then it will be assumed that he do not want to file reply to the Show Cause Notice and the Show Cause Notice will be decided in his absence on basis of case file.

Copy of Order be sent to the Registrar, Co-operative Societies, Punjab, Chandigarh for compliance of the Order.

Presently Ms. Suchneet Kaur Cheema is the Deputy Registrar, Co-operative Societies, Mohali. As submitted by the complainant/applicant in his representation that complete information has not been provided to him and he has brought some deficiencies to the notice of the PIO, so Ms. Suchneet Kaur Cheema, present PIO is directed that she should send the remaining information regarding the deficiencies to the complainant/applicant through registered post within 10 days and a copy of the same be sent to the Commission as compliance. In case of non compliance of the Order of the Commission a Show Cause Notice will be issued to her that why you have not complied with the Order of the Commission and so why you may not be penalized.
