- 2. During the hearing the appellant states that the respondent-Public Information Officer is not supplying the complete information. He also states that the respondent-Public Information Officer has not justified the amount demanded i.e. Rs.920/- for 460 pages. Furthermore the appellant states that he has deposited the said amount under protest and requested that the directions may be given to the respondent authority to refund the same as the information of only two pages have been supplied.
- 3. After point wise deliberations with both the parties, it has ascertained that the respondent authority was to demand Rs.920/- in another case of the appellant i.e. Appeal Case No. 2633 of 2019 and because of the RTI application(s) of the appellant the matter got intermingled. The respondent authority asked for the fees whereas no fees was required as per clarification submitted by the APIO. The APIO also states that the information comprising two pages has already been sent to the appellant vide letter No. XEN-1/95 dated 25.3.2021 and shall be considered as an information supplied to the appellant for the appeal case No. 2632 instead of the appeal case no. 2633. It has also ascertained that the appellant

sought the seven point information from the Commissioner, Municipal Corporation, District Amritsar, but as per the submissions of the representative of the respondents, the Municipal Corporation, District Amritsar is having only partial information comprising two pages which has already been supplied to the appellant. Regarding remaining information, the representative of the respondents states that it relates to the Public Information Officer o/o Amritsar Smart City Project.

- 4. As per Section 6(3) of the RTI Act, 2005 the respondents should have transferred the RTI application for remaining information to the concerned Public Authority. Since there was confusion in dealing with the RTI applications of the appellant, Commission is of the view that the RTI application regarding remaining information be transferred to concerned Public Authority now. However, the Commission further directs to the respondent-Public Information Officer o/o Municipal Corporation, District Amritsar to refund the amount of Rs.960/- which has been wrongly asked for by the respondent in this appeal case.
- 5. Accordingly, the respondent-Public Information Officer is directed to transfer the RTI application of the appellant regarding remaining points i.e. No.1, 5 to 7, to Sh. - 3. Regarding Point No. 3 of your application it is inform you that no such record, register is maintained from where the copy of the same can be retrieved. It is just like a research work and office of the undersigned has to go one by one to each file and to prepare the list which is nothing but creating a new information, which is not possible under RTI Act, 2005. Under RTI Act only that information can be provided which is available in the office record as such and not to prepare a new information. If any effort is made to do so at very definitely result in diverting the limited resources available with this public authority.
- 4. Regarding Point no. 4 of your application it is to inform to you that no record, register is maintained titled as illegal or unlawful building. Hence no such information exists from it is to be copied and cull-out. It is just like research work, which amounts to creating a new information which is not possible under RTI Act, 2005."
- 5. It is appropriate to mention the decision given by the Hon'ble Supreme Court of India in the matter of Central Board of Secondary Education & Anr. Vs. Aditya Bandopadhyay & Ors (Civil Appeal No.6454 of 2011) reported as 2011(3) RCT(Civil) as follows:-

"At this juncture, it is necessary to clear some misconceptions about the RTI Act. The RTI Act provides access to all information that is available and existing. This is clear from a combined reading of section 3 and the definitions of 'information' and 'right to information' under clauses (f) and (j) of section 2 of the Act. If a public authority has any information in the form of data or analysed data, or abstracts, or statistics, an applicant may access such information, subject to the exemptions in section 8 of the Act. But where the information sought is not a part of the record of a public authority, and where such information is not required to be maintained under any law or the rules or regulations of the public authority, the Act does not cast an obligation upon the public authority, to collect or collate such non available information and then furnish it to an applicant. A public authority is also not required to furnish information which require drawing of inferences and/or making of assumptions. It is also not required to provide 'advice' or 'opinion' to an applicant, nor required to obtain and furnish any 'opinion' or 'advice' to an applicant. The reference to 'opinion' or 'advice' in the definition of 'information' in section 2(f) of the Act, only refers to such material available in the records of the public authority. Many public authorities have, as a public relation exercise, provide advice, quidance and opinion to the citizens. But that is purely voluntary and should not be confused with any obligation under the RTI Act."

Public Grievances & pensions, department of Personnel & Training vide No. 10/2/2008-IR dated 12th June, 2008:-

- "....3(iii) A person makes an application to a public authority for information, a part of which is available with that public authority and the rest of the information is scattered with more than one other public authorities. In such a case, the PIO of the public authority receiving the application should give information relating to it and advise the applicant to make separate applications to the concerned public authorities for obtaining information from them. If no part of the information sought, is available with it but is scattered with more than one other public authorities, the PIO should inform the applicant that information is not available with the public authority and that the applicant should make separate applications to the concerned public authorities for obtaining information from them. It may be noted that the Act requires the supply of such information only which already exists and is held by the public authority or held under the control of the public authority. It is beyond the scope of the Act for a public authority to create information. Collection of information, parts of which are available with different public authorities, would amount to creation of information which a public authority under the Act is not required to do. At the same time, since the information is not related to anyone particular public authority, it is not the case where application should be transferred under sub-section (3) of Section 6 of the Act. It is pertinent to note that sub-section (3) refers to 'another public authority' and not 'other public authorities'. Use of singular form in the Act in this regard is important to note."
- 5. Keeping in view the judicial pronouncements, instructions issued by the Government of India viz a viz specific reply/information supplied to the appellant no directions are being given to the respondent-Public Information Officer/APIO to file the said reply in the shape of an affidavit as the same has already been filed by the APIO under his own signatures with which the Commission is satisfied.
- 6. A show cause notice was issued to Sh. Narinder Sharma, Public Information Officer o/o the Commission, Municipal Corporation District Amritsar on 6.1.2021 but the order of the Commission was not sent to him by name and also no reply has been received from him so far. In the interest of natural justice, one opportunity is granted to him to file his reply regarding show cause notice issued to him failing which ex-parte decision will be taken on the next date of hearing.
