Shr Vikram Vaid, appellant filed RTI application dated 04.12.2017 and he sought information regarding Shri Panna Lal, IO and Shri Surinder Mohan, SHO while attending as investigating officer on complaint recorded on 100 no. on dated 13.01.2014 and he sought the information from the office of the PIO through 12 paras which are as follows: -

1. Shri Panna Lal, ASI (IO) came to my residence along with SHO Shri Surinder Mohan for investigation of my complaint of attack by gunda element on dated 13.01.2014 at House No. 1527, Gali No.2, Bagh Ramanand, Amritsar. Please provide me the information regarding their duties as investigating officer in this matter.
2. Photocopy of Logbook page, copy of duty performing register (Roznamcha) in this case dated 13.01.2014 may please be provided.
3. Please provide the detail of attending/visiting during the visiting hospitals and disputed site for investigation/statements recorded in the crucial matter with copy of duty performing register (Roznamcha).

4. If any statement was taken by Shri Panna Lal (IO) and Shri Surinder Mohan (SHO) the detail of such statements of complainants/accused/witness along with copy of duty performing register (Roznamcha) may please be provided.
5. Detail of day to day till date action was taken by above officials after completing the investigation of my complaint.
6. Please provide me the detail of their [Surinder Mohan, (SHO), Panna Lal, ASI (IO)] duty period in Police Station E Division Kotwali from date of joining to date of releasing.
7. Please provide me the total no. of cases during their stay service period of Shri Panna Lal, ASI (IO) and Shri Surinder Mohan (SHO) in Police Station E Division Kotwali in which they are deputed to investigate the matter/complaint.
8. Detail of cases either cleared or closed and still pending in police station Kotwali E Division record during the above officials (Serial No.7) working period.
9. Shri Narain Singh ASI (IO) again deputed to investigate this matter in May, 2017 and he case to my residence. Please intimate the authority/Police Officer on whose order he performed the duty of investigation officer in this matter. Also, arrange attested photocopies of such orders.
10. Copy of duty performing register (Roznamcha) as investigation officer of Shri Narain Singh ASI in this case may please be provided.
11. Please provide me with the copy of final Enquiry Report with copy of duty performing register (Roznamcha) of Shri Narain Singh ASI in this case may please be provided.
12. If any record (MLR/X-ray films/city scan/final doctor opinion) is received from hospital in this case. The photocopies of same may please be provided. It is hereby cleared that doctors has replied under RTI Application that above documents were given to SHO, Police Station E Division kotwali.”

The present appeal case was previously heard by the Bench of the Hon'ble Chief Information Commissioner, Punjab, Dr. S.S. Channi and on his retirement the case file was sent to the present Bench for hearing.

On 19.03.2019 the Hon'ble Chief Information Commissioner, Punjab, Dr. S.S. Channi directed the PIO to submit reply through affidavit that the record is not available and in compliance to the Order, Shri Bhupinder Singh, PPS, PIO-cum-Deputy Commissioner of Police, Amritsar has sent a duly attested affidavit dated 19.07.2019 duly attested by Executive Magistrate, Amritsar along with copy of Order of destruction through which the record was

destroyed. The affidavit along with copy of Order of destruction were taken in the file of the Commission and another copy of the affidavit along with copy of Order of destruction were handed over to the appellant on the same date.

I have gone through the Order dated 29.07.2019 and the appeal case was adjourned for today i.e. 11.09.2019.

Shri Vikram Vaid, appellant has sent a mail, which was received in the office of the Commission on 26.08.2019 and diarized vide no.16160 and another copy of the said mail is sent to the office of Hon'ble Chief Information Commissioner, Punjab, Shri Suresh Arora.

On the other hand the Commissioner of Police, Amritsar has sent a mail to the office of Hon'ble Chief Information Commissioner, Punjab, Shri Suresh Arora, which is a copy of letter no.3920/CPC dated 03.09.2019. I have gone through the said letter and also gone through the mail sent by the appellant, Shri Vikram Vaid.

The appellant is seeking information regarding Shri Panna Lal, IO and Shri Surinder Mohan, SHO and he sought information through para nos. 1 to 12 of the RTI application.

Shri Bhupinder Singh, PPS, PIO-cum-Deputy Commissioner of Police, Amritsar has sent a duly attested affidavit dated 19.07.2019 attested by Executive Magistrate, Amritsar along with copy of Order of destruction through which the record was destroyed. Copies of both the documents were handed over to the appellant on the last date of hearing.

I have gone through the contents of the affidavit submitted by Shri Bhupinder Singh, PIO and it is submitted that no record is available in the office of the PIO regarding para nos.1, 5, 7, 8 and 12 of the RTI application.

In para 2 of the affidavit it is submitted that information related to para nos.2, 3 and 4 of the RTI application copies of Roznamcha were destroyed after the period of two years and he has sent along with the copy of Order of destruction.

In para 4 of the affidavit, which is related with para no. 6 of the RTI application, it is submitted that Inspector Suresh Mohan remained posted as SHO, Police Station E Division from 18.09.2013 to 14.02.2014 and ASI Panna Lal remained posted at Police station E Division from 18.04.2013 to 14.02.2014.

In para 6 of the affidavit which is related with para no. 9 of the RTI application it is submitted that the application was marked for inquiry by Inspector Gurbinder Singh, SHO, Police Station E Division, Amritsar to ASI Narain Singh in the month of May, 2017.

In para 7 of the affidavit which relates with para no.10 of the RTI application it is submitted that no separate performing register was prepared in police station.

In para 8 of the affidavit which relates with para no.11 of the RTI application it is submitted that information relating to this para has already been provided through letter no.2571-CPC dated 23.05.2017.

Shri Bhupinder Singh, PPS, PIO-cum-Deputy Commissioner of Police, Amritsar has replied each and every point of the RTI application through duly attested affidavit dated 19.07.2019. I have discussed each point of the RTI application and also discussed the affidavit with the appellant.

So as per the affidavit submitted by the PIO, Shri Bhupinder Singh that he has provided the information which was available in his office. Some information as discussed above is not available in the office of the PIO and some information has been destroyed vide Order of destruction submitted by the PIO.

The PIO has resolved the matter involved in the RTI application, specifically para-wise. So, as per the affidavit dated 19.07.2019 submitted by the PIO, the present appeal case is **disposed of and closed**.
