1. This order may be read with reference to the order dated 19.07.2021 passed by this Bench on the previous date of hearing.
2. The case has been heard today. Shri Raj Kumar, appellant comes present to attend the hearing in person before the Bench.
3. Shri Jeewan Singh, Senior Assistant also comes present to attend the hearing in person before the Bench on behalf of the PIO. He states that the appellant was called to their office for inspection of record as per directions of Hon'ble Bench. He visited on 06.08.2021 and was shown relevant record, but he has not inspected and identified any documents/information needed by him. He further states that the appellant has been given point-wise information vide letter dated 01.09.2021.
4. On the asking of the Bench, Shri Raj Kumar, appellant explains the need of his asking for the information vide his RTI application as he has been asked to produce N.O.C. from PDA Patiala for

registration of Title Deed of plot purchased by him whereas the Tehsildar, Lehra has been registering the Title Deeds without NOC in some other cases. He also states that he is not satisfied with the information supplied as the same is partial and unsatisfactory information.

5. Post deliberations, the PIO is directed to call the appellant again to his office on any working day by tying up with him and allow him access to the official records. The appellant will identify the information after inspection of records and the same will be provided by the PIO before the next hearing duly attested.

6. After supplying information to the appellant, the PIO is also directed to file an affidavit on non-judicial stamp paper, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.792 of 2021 has been supplied to the appellant. It be further stated that nothing has been concealed therein and the statement made is true and correct. The Estate Officer/PIO is directed to come in person before the Bench and bring along original affidavit along with its photocopy as also the relevant official records and the same be produced before the Bench on the next hearing.

7. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 12.01.2022 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
