

Since the RTI application has been replied to sufficiently, no further interference of the Commission is required. The case is **disposed of and closed.**



ORDER:

The appellant through the RTI application dated 17.07.2020 has sought information regarding a copy of the application dated 06.03.2020 alongwith action taken thereon and enquiry report, noting etc. as enumerated in the RTI application from the office of DC Mansa. However, the PIO had not sent a copy of the information to the Commission as per the earlier order dated 16.08.2021.

The appellant was directed to point out the discrepancies in the provided information in writing to the PIO and the PIO was directed to sort out the same.
