ORDER:

The complainant through RTI application dated 26.02.2019 has sought information 9 points regarding drawing number of T.P.Schme-1 part-3 under which the roads and streets are constructed and other information concerning the office of SSP Civil Secretariat, Moga. The complainant was not satisfied with the reply of the PIO dated 11.03.2019 after which the complainant filed a complaint in the Commission on 05.07.2019.

The respondent present pleaded that since the information is available in the form of a map, the complainant was asked vide letter dated 11.03.2029 to deposit requisite fee of Rs.2000/- and get the information but the complainant has not deposited the fee.

Having gone through the record, the Commission observes that the PIO has replied to the complainant within the prescribed time. The complainant is not satisfied. If the complainant wants to get the information, he is directed to go the First Appellate Authority.

The case is remanded back to the Chief Town Planner, BDA Bathinda, which is the First Appellate Authority. The First Appellate Authority is directed to dispose off the appeal within 30 days.

ORDER:

ORDER:

The appellant through RTI application dated 20.02.2019 has sought information on 7 points regarding documents/school college certificate/degrees attached with the application for appointment by Baba Rajinder Pal Singh, Pump Operator alongwith attendance record, leave record and other information concerning the office of GLADA Ludhiana. Having gone through the record, the Commission observes that even though the appellant has claimed that the information is not personal and the appointment is made by the said record and that the log book also pertains to service record, however, the appellant has failed to provide any evidence which establishes that the disclosure of information has a larger public interest. I uphold the view of the PIO and dismiss the appeal.
