APPEAL CASE NO. 1703 of 2014

Present: Nobody present.
ORDER

1. Notice for compliance of order of the Commission dated 12.09.2014 through which penalty amounting Rs. 5,000/- (Five Thousand) was imposed on Sh. Nirmal Jeet Verma (PIO-cum-Building Inspector), Municipal Corporation, Ludhiana was sent to the Commissioner, Municipal Corporation, Jalandhar but till date no compliance report has been received from the respondent. Accordingly the case is fixed for today.
2. Neither the respondent PIO is present for today's hearing nor did he file reply in this regard, which shows no regard to the Notice of the Commission as well as of the RTI Act.
3. Sh. Rakesh Kumar Dhamija, Son of the appellant intimated the Commission through telephonic message that his father is no more.
4. After examining the case file, another opportunity is given to the respondent PIO to appear in person along with directions to comply with the previous order of the Commission dated 12.09.2014. He is also directed to bring the copy of challan, on the next date of hearing to clear the facts of this case.
5. It is also observed that as per the case file, Sh. Nirma Jeet Verma stood transferred from the O/o MC, Ludhiana to the O/o MC, Jalandhar. Nirmal Jeet Verma to represent this case along with directions to comply with the previous order of the Commission dated 12.09.2014. He is also directed to bring the copy of challan, on the next date of hearing to clear the facts of this case.

6. The above mentioned case is pending only for the penalty to be deposited as per the previous order of the Commission dated 12.09.2014 so only respondent PIO is bound to represent this case.
