ORDER:

1. The RTI application is dated **13.2.2020** vide which the appellant has sought information **regarding showroom workshop service centers for cars under the jurisdiction of Municipal Corporation Ludhiana**, as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on **13.3.2020** and second appeal was filed in the Commission on **18.6.2020** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **11.12.2020**.

2. Both parties are present through Video Conference Facility. The respondent PIO, represented by Harpreet Singh, Assistant Environment Engineer and Bachan Pal Singh, Assistant Environment Engineer stated that two separate replies were sent to the appellant vide letter No.3935 dated 10.6.2020 and letter No.522 dated 20.10.2020. In the second letter, the appellant was invited to inspect the official record on any working day between 9.00 AM to 5.00 PM.

3. The appellant however, says that he was not permitted to conduct any inspection when he visited the office of PPCB, Regional office-I. This Commission directs the respondent PIO, Regional Office-I to arrange for another inspection by the appellant after 2.30 P.M. on 16.12.2020.
