ORDER:

1. The RTI application is dated **27.7.2020** vide which the appellant has sought information **regarding electricity meter installed at House No. 49 Doctor Ambedkar Nagar Opposite office of electricity Model Town, Ludhiana**, as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on **11.9.2020** and second appeal was filed in the Commission on **5.11.2020** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **11.2.2021**.

2. The appellant is absent without intimation. The respondent PIO, represented by M.P.
