2. The representative of the respondents states that the action taken as has been sought by the complainant has already supplied as the enquiry has been marked to the Deputy Commissioner, Patiala and the same is awaited. A letter bearing No. 972 dated 27.1.2021 has also been received from the respondent-Public Information Officer which is taken on record. Furthermore, he requested to close the case as the action taken as has been sought has already been provided. However, the complainant states that he has not received the letter written to the Deputy Commissioner, Patiala and requested for the same. ORDER

The RTI application is dated 20.7.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 19.10.2020 and second appeal was filed in the Commission on 14.12.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information:-

3. The representative of the respondents states that the RTI application of the appellant has been transferred under Section 6(3) of the RTI Act, 2005 to the Deputy Commissioner, District Ludhiana.

4. It has come to light that the appellant has already sought the similar information from the Financial Commissioner Revenue/Deputy Commissioner and filed the 2nd appeals bearing Appeal Case No. 3175 of 2020 listed for hearing before the Commission on 3.3.2021. Since the appellant has already sought the information from the Deputy Commissioner, District Ludhiana, accordingly, the Commission observes that no further action is required to be taken in this case. Therefore, this case of the appellant is disposed of and closed.
