PRESENT: (Complainant) Absent Harinder Singh, Senior Assistant (for the Respondent) 98885-70052

ORDER:

1. The complainant, Jagdeep Singh, filed this RTI application dated 1.3.2021 and sought information regarding chargesheets against officer/s pertaining to the lining of the Karam Patti Minor in 2014, from the PIO o/o Secretary, Irrigation Department, Pb., Chandigarh. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on 16.9.2021. Notice was issued to the parties for first hearing in the Commission on 11.3.2021.

2. The complainant is absent without intimation. The respondent PIO, represented by Harinder Singh, Senior Assistant, has made a submission vide Letter No. 122 Dated 22.2.2022 that the complainant was informed vide Letter No. 253/1 Dated 19.4.2021 that the information is sought was nonspecific in nature. Following further exchange of letters between the PIO and complainant, the latter was eventually denied the information vide Letter Dated 570 dated 13.8.2021 citing the Department of Governance Reforms & Public Grievances Letter No. 4/5/2021-4GP1/225467/2021 Dated 8.9.2021 citing the Hon'ble Supreme Court's Judgment in Civil Writ Petition No. 10044 of 2010:

"Reading of the aforesaid judicial precedents, in our opinion, would indicate that personal records, including name, address, physical, mental and psychological status, marks obtained, grades and answer sheets, are all treated as personal information. Similarly, professional records including qualification, performance, evaluation reports, ACRs, disciplinary proceedings, etc. are all personal information. Medical records, treatment, choice of medicine, list of hospitals and doctors visited, findings recorded, including that of the family members, information relating to assets, liabilities, income tax returns, details of investments, landing and borrowing, etc. are personal information. Such personal information is entitled to protection from unwarranted invasion of privacy and conditional access is available when stipulation of larger public interest is satisfied. This list is indicative and not exhaustive."
