3. The complainant has sent the written submission in this case, which is taken on record. The complainant also filed the complaint case in the Commission on 11.1.2022 vide which he has requested for the information in this case.

4. It is appropriate to mention the decision of the Hon'ble Supreme Court of India in Civil Appeal Nos.10787 – 10788 of 2011 (arising out of SLP @ No.32768-32769/2010) in which it has held that while entertaining a complaint under Section 18 of the RTI Act, 2005, the Commissioners have no jurisdiction to pass an order providing for an access to the information. Since the complainant has approached the Commission under the provisions of Section 18 of the RTI Act, 2005, no directions for providing further information can be given by the Commission.

An alternative and efficacious remedy of first appeal is available to the complainant under Section 19(1) of the RTI Act, 2005 which has not been availed in the instant case.

5. Therefore, the matter is remanded back to Sh. Jugraj Singh Randhawa, 8437399399 District Education Officer (SE)-cum-First Appellate Authority, Amritsar to take appropriate decision in accordance with the provisions of the RTI Act within the prescribed time, after giving opportunity of hearing to all concerned by passing a speaking order with one month. A copy of the complaint filed before the Commission is also being sent to him along with this order with the directions that the said may be treated as first appeal.

5. With these directions the present case is disposed of and closed. However, the liberty is granted to the complainant to file the 2nd appeal in this case, if he is not satisfied with the decision of the First Appellate Authority.
