1. The RTI application is dated **27.6.19** vide which the appellant has sought **information by way of the roznamcha of Police Station Dakha from 25.6.19 to 26.6.19; copies of log books for vehicles of the police station; and the CCTV footage between 12:00 and 2:00 pm on 27.6.19**, as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on **3.8.19**, and second appeal was filed in the Commission on **9.10.19** under section 19 of the Right to Information Act, 2005. The case was last heard on **6.1.2021**.

2. The appellant is absent without intimation. It is notable here that the appellant has not attended a single hearing since he filed this appeal case. The respondent PIO, represented by ASI Darshan Singh, is present via Video Conference from Ludhiana. At the last hearing on 6.1.2021, the respondent PIO was directed to supply the requested CCTV footage and copies of Log Book for the vehicle at Police Station, Dakha as requested in the RTI application. The respondent PIO was also issued a Show Cause Notice for deliberately delaying the information requested in this RTI application.

3. In a reply to Show Cause Notice dated 7.4.2021, the respondent PIO has made a detailed submission stating that the copies of DDR's/roznamcha and the log books as requested in the RTI application have already been supplied to the appellant. As regards to CCTV footage, he has stated that the system, which is managed by a private NOIDA-based concern, gets automatically deleted after a period of 70 days.

4. It is notable here that the CCTV footage requested was between 12.00 noon and 2.00 pm on 27.6.2019. Considering the fact that the RTI request was received on 27.6.2019 which is well within the stated 70 days period, the concerned SHO-cum-PIO, Police Station, Dakha should have ensured the safe keeping of the requested CCTV footage until the resolution of this request. He has failed to do so and deserves censure for his conduct.

5. However, in light of the respondent PIO's written submission and the continuing absence of the appellant in this appeal case, the Commission is compelled to conclude that the appellant is satisfied with the information furnished by the respondent PIO.

6. Under the circumstances, there is no further cause for action and this appeal case is herewith **CLOSED.**
