The Block Development and Panchayats Officer, Samana shall ensure that this amount of penalty is deducted from the salary of the above said defaulting official for the month of September, 2020 and deposited in the Treasury under the relevant head and sent compliance report to the Commission on or before 20.10.2020.
- 10. Also the Public Information Officer-cum-Block Development and Panchayats Officer, Samana is directed to make available the record for inspection of the complainant and provide the copies of documents if so identified by him pertaining to the year 2010-2013 failing which the action will be initiated against him under the provisions of the RTI Act, 2005 on the next date of hearing.
