1. The above mentioned case was last heard by the bench of Ld. SIC, Sh. Yashvir Mahajan dated 03.09.2019 and allotted to the bench of undersigned vide Office Order dated 08.11.2019 passed by the Hon'ble Chief Information Commissioner, Punjab. Accordingly, the case is fixed for hearing today.
2. Complainant, Sh. Surinderjit Singh states that required information is still pending from the respondent PIO.
3. Neither the respondent PIO is present for today's hearing nor did he file reply in this regard. He was also absent on the previous hearing held on 06.02.2019 and 03.04.2019. Show Cause notice was issued to him vide order dated 03.04.2019.
4. I am of the view that due to evasive attitude of the respondent PIO concerned, the complainant has suffered a lot of detriments for not getting the requisite information, I am of the view that compensation be awarded to the appellant, Sh. Surinderjit Singh.

Hence, I award an interim compensation of Rs. 2,000/- (Two Thousand Only) to the appellant. The compensation amount must be paid by the respondent PIO concerned through cheque or demand draft in favor of **Surinderjit Singh** from the account of Public Authority and not from the individual's account.

Respondent PIO is directed to produce a copy of the cheque or demand draft on the next date of hearing.

5. Respondent PIO is directed to appear in person to clear the facts of this case before the Commission on the next date of hearing positively along with directions to file a reply to the Show Cause notice issued to him dated 03.04.2019.
6. Matter is adjourned for further hearing on **17.03.2020 at 11:00 A.M.**
