**Present:-** Shri Mukesh Kumar, appellant is present.  
None present on behalf of the SPIO, O/o Secretary, Health, Punjab, Chandigarh.

**O R D E R**

Shri Mukesh Kumar, appellant filed RTI application dated 11.02.2020 and sought some information from the SPIO, O/o Secretary, Health, Punjab, Chandigarh. When no information was provided to him by the SPIO, then he filed First Appeal before the First Appellate Authority on 15.06.2020. A reply was sent to him by the SPIO vide letter no.1373 dated 24.07.2020. But not satisfied with the reply the appellant filed Second Appeal before the Punjab State Information Commission on 27.10.2020. The case was registered and allocated to the Bench. Notice of hearing was issued to both the parties for today to be heard through **CISCO Webex Meetings Software.**

The appellant is present today, but none has appeared on behalf of the SPIO. The appellant stated that the sought for information has not been provided to him by the SPIO till today.

The SPIO though is absent today, but he has sent a mail to the Commission on 18.12.2020, diarized vide no.18834, which is a copy of letter no.4520 dated 11.12.2020. I have gone through the said letter and it is submitted by the SPIO that the concerned file is not available in the office of the public authority and hence the information sought by the appellant cannot be provided to him.

So, as per the reply sent by the SPIO that the concerned file is not available in the office of the public authority and the information cannot be provided to the appellant, hence the present appeal case is **disposed of and closed.**

**O R D E R**

Shri Amarjit Singh Dhamotia, appellant filed RTI application dated 03.08.2020 and sought some information from the SPIO, O/o DCP (Traffic), Ludhiana. When no information was provided to him by the SPIO then he filed First Appeal before the First Appellate Authority on 07.09.2020 and then Second Appeal before the Punjab State Information Commission on 29.10.2020. The case was registered and allocated to the Bench. Notice of hearing was issued to both the parties for today **through CISCO Webex Meetings Software**.

The appellant is absent today, whereas the respondent has appeared on behalf of the SPIO and he stated that the sought for information, specifically para-wise, has been sent to the appellant vide letter no. 15-RTI dated 05.09.2020.

The appellant though is absent today, but he has informed the Commission telephonically that he has received the information sent by the SPIO, but the information is not complete.

The Commission has received a mail sent by the SPIO on 24.12.2020, diarized vide no. 19298, which is a copy of letter no. 15-RTI dated 21.12.2020 along with a copy of letter no.15-RTI dated 05.09.2020 and a photocopy of postal receipt dated 09.09.2020.

I have gone through the RTI application dated 03.08.2020 and also gone through letter no.15-RTI dated 05.09.2020. The SPIO has given information/reply to each and every para of the RTI application and resolved the matter. So, the present appeal case is **disposed of and closed**.
