The Complainant, Sh. Surjit Singh is absent in today's hearing, so no statement could be recorded.

After discussing with the PIO and going through the case file, the Respondent/PIO is advised to supply the requisite information to the Complainant through registered post by or on the next date of hearing. The Respondent/PIO is further advised to appear in person or through any of his representative on the next date of hearing. The Complainant is advised to point out the deficiencies through registered post to the Respondent/PIO, if any, once he receives the requisite information from the Respondent/PIO. The Complainant is given a last opportunity to appear in person or through any of his representative on the next date of hearing, failing to which the case will be decided on merits.
