ORDER

This order may be read with reference to the previous order dated 30.01.2020, vide which both the parties were advised to appear before the Commission with the original record for the perusal of the Commission.

2. The appellant states that he has some documents concerning Khasra No.182, which the representative of the respondents states that there are two kinds of files maintained under the Revenue Act, one is 'Parat Patwar' and 'Parat Sarkar'. Each entry is made on Parat Patwar and after its finalization/four years, final entry is made in Parat Sarkar and the said record is available in Sadar Kanugo's Branch. Record (Parat Patwar) is available with Patwari and every event is recorded in that. He produced the record of Parat Patwar, which is mutilated. The respondent requests that to help out the appellant, he may be asked to inspect the record on any working day and get copy of any document, which he requires.

3. After hearing the parties and going through the record available on the case file, it is revealed that record produced by the representative of the respondents is mutilated. On the request of the representative of the respondents, the appellant is advised to inspect the record on 15.02.2020 at 11.00 A.M. in respondent's office and get copy of any record after identification on the spot. The respondents are directed to get the record inspected on 15.02.2020 (Saturday) at 11.00 A.M. and supply copy of any documents on identification as per his RTI application under the provisions of RTI Act, 2005, on the spot.
