Surinder Pal by submitting a writing submission to the Appellant by hand of dated 12.03.2021 during the hearing and a copy of same has been submitted to Commission as well vide dated 12.03.2021, which is taken on record.

On this, the Appellant, Sh. Janak Singh shows his satisfaction today but further states that the same written submission which has been given to him today by the Department could have been given to him well in time from the date of RTI Application.

In view of above, as the Appellant shows his satisfaction. So, no further intervention is required in this case.

This order may be read with the reference of the previous order dated 03.03.2021.

In today's hearing, the Appellant, Sh. Janak Singh and from the Department, Sh. Surinder Pal Panchayat Secretary is present today.

After having the point wise discussion with both the parties, it has been found that the Appellant is satisfied with the information relating to point number 1(1), 1(3) and information relating to 1 (2) and 1(4) is pending in nature and requests for the same. He further states that the Department is sending him vague replies vide 01.10.2020 which doesnot relate to this case.

On further discussion, Sh. Surinder Pal, Panchayat Secretary states that at the time of RTI Application he was not there but still he looked into this matter and in regard of the orders of the Commission each and everything has been supplied to the Appellant in relating to this case.

Moreover after having the point wise discussion with both parties, it has been found that the queries raised by the Appellant during the proceedings of the Court is resolved by the Panchayat Secretary, Sh. Surinder Pal by submitting a writing submission to the Commission vide dated 12.03.2021, which is taken on record.

On this, the Appellant, Sh. Janak Singh shows his dissatisfaction and doesnot collect the written submission from the Department during the hearing and further states that he doesnot want the reply from Sh. Surinder Pal as he requests for information from O/o BDPO, Majri. The Appellant, Sh. Janak Singh also states that he has been harassed by the Department as they could have given the information well in time.

After going through previous hearings, it has been observed that the Appellant was satisfied with the information supplied to him in this present case which is mentioned in the hearing dated 16.04.2019 of this instant case but in further order he requested the court that this information is not according to his satisfaction due to which the concerned Department was directed to supply the information to the Appellant accordingly.
