I have gone through the above mentioned letters. The complainant/applicant, Shri Jatinder Singh filed RTI application on 13.02.2019. As no identity proof was annexed with the RTI application, so the PIO wrote letter no.699/CPC dated 20.02.2019 to the complainant/applicant that your identity proof is not received with the RTI application. Instead of filing identity proof with the office of the PIO, the complainant/applicant filed complaint before the Punjab State Information Commission.

The RTI application was filed on 13.02.2019, whereas reply was sent by the PIO on 20.02.2019, within a week, within the stipulated period of 30 days. So. no complaint lies against the PIO, when he has replied within the stipulated period. It is advisable for the

complainant/applicant that instead of filing the complaint he should send the identity proof to the office of the PIO.

So, in the light of circumstances and facts of the case, the present complaint case is disposed of and closed with the observation that in case the complainant/applicant wants to get the information, then he should provide his identity proof with the office of the PIO within 3 days and in case the complainant/applicant submits his identity proof then the PIO should provide the sought for information to the complainant/applicant within 15 days.

With this observation the present complaint case is **disposed of and closed**.
