**ORDER**

The judgment in this case was reserved vide orders dated 04.06.2021.

2. This order may be read with reference to the previous orders passed in this case on different dates. Vide orders dated 18.11.2020 the Respondents were directed to provide the information regarding Tower Location to the Appellant.

3. A letter dated 08.02.2021, has been received from the Respondents through which they have intimated that information relating to call details and tower location cannot be provided because the same is “*older than one year*”. It has further been intimated that remaining information as available in the official record has been provided. He further states that Smt Gurbinder kaur wife of the Appellant, Sh Ranjit Singh appeared in their office on behalf of the Appellant on 01.02.2021 and obtained the information by hand.
