**This case may be read with the reference of the previous order dated 22.03.2022.**

In today's hearing, the Appellant, Sh. Yogesh Mahajan states that no information has been supplied to him.

On this SDE, Sh. Raminderjeet Singh states that the information is ready with them and it would be sent to the Appellant within two days. On further discussion with the representative of the concerned PIO it has been found that the penalty (i.e. Rs. 10,000/- imposed vide order dated 21.12.2021) has not been deposited by the concerned PIO to the Government Treasury till date.

After going through the case file, it has been observed that information is still not supplied to the Appellant and the penalty was imposed to the concerned PIO vide orders dated 21.12.2021 is also not deposited and moreover, on the last hearing dated 22.03.2022 an opportunity was given to the concerned PIO to comply the orders of the Commission **but PIO fails to do so.**

**Commission takes a serious view of the casual approach of the Respondent / PIO as despite of giving many opportunities to the concerned PIO, not a single order of the Commission has been complied.**

**In view of above, the amount of penalty of Rs. 10,000/- which was imposed vide order dated 21.12.2021 be enhanced by Rs. 10,000 (i.e. enhanced today) which comes to total amounting to Rs.20,000/- (Rupees Twenty Thousand Only) is imposed upon the concerned PIO o/o the Executive Engineer, Water Supply and Sanitation Division Number 02, Sri Muktsar Sahib.**
