2. In today's hearing, both the parties are present. Appellant, Sh. Vikul states that requisite information is still pending from the respondent PIO.
3. Respondent, Sh. Janak Raj Mehrok states that reply has already been sent to the appellant. He adds that information can be given for Rs.200/- per page as per prescribed fee decided by the concerned authorities.
4. After hearing both the parties and examining the documents placed on record, both the parties are directed to appear in person on the next date of hearing at Punjab State Information Commission, Chandigarh office on **21.10.2021 at 11:00 A.M.** along with documents concerned with this present case, to clear the facts positively.
