Shri Yogesh Maini, appellant filed RTI application dated 22.01.2021 and sought some information from the SPIO, O/o Asstt. Commissioner of Police, Ludhiana. When no information was provided to him by the SPIO, then he filed First Appeal before the First Appellate Authority on 23.02.2021 and then Second Appeal before the Punjab State Information Commission on 15.04.2021. The case was registered and allocated to the Bench. Notice of hearing was issued to both the parties for today through CISCO Webex Meetings Software.

The appellant is present today, whereas the respondent is absent.

The appellant stated that he has filed RTI application on 22.01.2021 and sought information regarding the complaints filed by him.

The SPIO though is absent today, but he has sent an e-mail to the Commission, which is a copy of letter no.609-D dated 10.08.2021. I have gone through the said letter and it is submitted by the SPIO that complaint nos. 1891210 dated 02.10.2020 and 1884073 dated 23.09.2020 filed by the appellant are still under investigation before the Joint Commissioner of Police, Ludhiana and is exempted U/s 8(1)(h) of the RTI Act, 2005. It is further submitted by the SPIO that the investigation regarding complaint no. 1872938 dated 10.09.2020 has been completed and the information was sent to the appellant through registered post on 10.08.2021.

The investigation regarding complaint nos.1891210 dated 02.10.2020 and 1884073 dated 23.09.2020 are still pending before the Joint Commissioner of Police, Ludhiana and the respondent claimed exemption U/s 8(1)(h) of the RTI Act, 2005. So, the present appeal case is **disposed of and closed** with the observation that whenever the investigation will be completed in the above said complaints, then the attested copies of information be sent to the appellant through registered post within 10 days from the completion of inquiry and compliance report be sent back to the Commission.
